**When people say,**

*“It’s a woman’s right to choose.”*

**You can say,**

“Once a woman is pregnant, she already has a child; the choice is what to do with him or her. Although the word ‘choice’ sounds positive, the actual choice is whether to have a *live child* or a *dead child*.”

# ABORTION ON DEMAND IN AMERICA

## Legal for Any Reason for All Nine Months

*Roe v. Wade* and its companion decision *Doe v. Bolton* legalized abortion on demand for any reason for the **full nine months** of pregnancy. (Note: In the Supreme Court, companion decisions are meant to be read together in order to get the complete effect of the ruling.)

*Roe* said:

“For the stage subsequent to viability, the State, in promoting its interest in the potentiality of human life, may, if it chooses, regulate, and even proscribe abortion, except where it is necessary, in appropriate medical judgment for the preservation of the life or health of the mother.”

—*Roe v. Wade* (U.S. Supreme Court No. 70-18, XI, p. 49, January 1973)

Then *Doe*, the companion decision, defined “Health . . .”

**“ . . . in light of all factors—physical, emotional, psychological, familial, and the woman’s age—relevant to the well-being of the patient. All these factors may relate to health.”**

—*Doe v. Bolton* (U.S. Supreme Court No. 70-40, IV, p. 11, January 1973)

(That means that a 27-year-old at *any* stage of her pregnancy could state either that she is “too old” or “too young” to have a child, and an abortion would be perfectly legal under *Doe v. Bolton* since “age” is a factor of health.)

## The Individual Child’s Development in the Womb

All that is added to the new human life from the moment of fertilization is time and nourishment . . . the same as for any growing child, teen, or adult.

At **conception** a genetic code exists that is completely different from that of the mother. About half of the time the baby’s sex differs from the mother.

At **18 days** (before the mother even knows she’s pregnant) her unborn baby’s heart is beating. (Abortionists usually do not let the mother considering an abortion hear the heartbeat or even tell her it exists.)

At **19 days** the baby’s eyes begin to develop.

At **four weeks** the baby’s arms and legs begin to develop.

At **five weeks** the baby’s mouth, ears, and nose are taking shape.

At **six weeks** the baby kicks and has measurable brain waves.

At **eight weeks** all body systems are present—the baby sucks his thumb and can feel pain.

At **10 weeks** the structure of the baby’s body is completely formed—even fingerprints and eyelashes.

At **11 weeks**, in the first trimester, the baby’s organ systems are complete and functioning: he or she breathes (fluid), swallows, digests, sleeps, dreams, wakes, tastes, hears, feels pain, and can be taught things.

*From this point on, the baby grows only in size.*
